2011 FLC Interagency Partnership Award Nomination Form

The FLC Interagency Partnership Award recognizes the efforts of federal science and technology employees from at least two different agencies who have collaboratively accomplished outstanding work in the process of transferring a technology.

Award Criteria

Nominees of the 2011 Interagency Partnership Award will be judged on the following criteria:

1. Outstanding cooperative effort by federal science and technology employees from laboratories representing two or more Federal agencies in the transfer of a specific technology, product, or service that has been adopted by and/or benefits another Federal agency or private sector entity for government or non-government use.
2. Specific attributes of the respective agency laboratories that enabled the effective transfer of the technology.
3. The transfer of the technology must have occurred within the past five years.

Submission Guidelines

- Describe the nominee’s accomplishments and why you think they should receive the award.
- Only FLC Agency or Laboratory Representatives may submit a maximum of one nomination each.
- Nominees must be employees of FLC member laboratories.
- Nomination narrative should not exceed **three** pages.
- Use Arial or Times font styles that are no smaller than 10 points.
- Do not attach supporting documentation (e.g. brochures, newspaper articles, press releases)
- Section A and Section B of the nomination form must be sent electronically to the FLC Management Support Office at **mchambers@utrs.com**.

Both the Nomination form and Submission Verification form must be received by the FLC Management Support Office by 8:00 p.m. EDT (5:00 p.m. PDT) on **Thursday, October 14, 2010**. No submissions will be accepted after this time.

Announcement of Results

The winners of the 2011 FLC Interagency Partnership Award will be announced on **December 16, 2010**. Laboratories submitting nominations will be notified prior to the official announcement.

Award Ceremony

Winners will be honored during an awards banquet to be held May 5, 2011 at the FLC National Meeting in Nashville, Tennessee.
